Invitation for Bids

1. *Gangajamuna Rural Municipality* has allocated funds toward the cost of following projects and intends to apply part of the funds to cover eligible payments under the contract. Bidding is open to all eligible Bidders.
2. Gangajamuna Rural Municipality invites electronic bids from Nepalese eligible bidders for the construction under National Competitive Bidding procedures.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the PPMO website www.bolpatra.gov.np/egp.
4. Bidder who needs to submit their bid electronically may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost(as specified) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held at *the Office of Gangajamuna Rural Municipality* at **12:00 14/09/2021 (29/05/2078)**.
6. Electronic bids must be submitted to the office of *Gangajamuna Rural Municipality* through PPMO website www.bolpatra.gov.np/egp on or before **12:00 on 28th September 2021** Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 on 28th September 2021** at the office of Gangajamuna Rural Municipality, Phulkharka, Dhading. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **mentioned amount for each project**, which shall be valid for **30 days** beyond the validity period of the bid (i.e. 120 days)
7. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date.
