**Invitation for Sealed Quotation for procurement of Fabricated Steel Parts for Trail Bridge**

1. **The Government of Nepal (GoN)** has allocated TB-SWAp funds to **Gangajamuna Rural Municipality** for **Trail Bridge Program** and the Rural Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridge. Bid is open to all eligible Nepalese Bidders.
2. The **Gangajamuna Rural Municipality** invites sealed Quotation from registered fabricators for supply of fabricated steel parts for following Trail Bridge. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Document.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted in [www.nepaltrailbridges.org.np](http://www.nepaltrailbridges.org.np) may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
4. Eligible Bidders may obtain further information at the office of **Gangajamuna Rural Municipality** and inspect the bidding document in [www.ppmo.gov.np](http://www.ppmo.gov.np)
5. Bidding document may be purchased from **www.ppmo.gov.np** by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until the (last date of purchase of bidding document) **(14/Nov/2021AD or 2078/07/28)** from the first date of publication of this notice.
6. Bids must be submitted through [www.bolpatra.gov.np](http://www.bolpatra.gov.np), on or before **12:00 noon on (15/Nov/2021 or 2078/07/29.)**. Documents received after this deadline shall not be accepted.
7. Bids will be opened in the presence of Bidders' representatives who choose to attend at **Gangajamuna Rural Municipality** on **13:00 on 15/Nov/2021 or 2078/07/29** at the office of **Gangajamuna Rural Municipality**, Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security, amounting to a minimum of **33,000**, which shall be valid for **30 days** beyond the bid validity period.
8. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit in **Nepal SBI Bank (Account mantained at Gangajamuna Branch) Security deposit (Dharauti) Account Number: 43025240600003** and submit bank deposit voucher along with the bid.
9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
