- १। Gangajamuna Rural Municipality *has allocated funds* towards the cost of **Gangajamuna Tourism Infrastructure Development Project** and intends to apply part of the funds to cover eligible payments under the **Contract ID No GRM/DHADING/25/077-78**. Bidding is open to all eligible bidders as per Section V of bidding document.
- २। **Gangajamuna Rural Municipality** invites electronic bids from eligible bidders for the construction of works mentioned above under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
- ३। Only eligible bidders with the following key qualifications should participate in this bidding:
- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **Nrs. 4,00,00,000.00**
 - Minimum work experience of similar size and nature: Archaeological or Religious Monuments related construction experience with **value Nrs. 4,50,00000.00 and must have experience of Stone sculpting.**
- ४। Eligible Bidders may obtain further information through PPMO e-GP system www.bolpatra.gov.np/egp or may visit Gangajamuna Rural Municipality office.
- ५। Bidders may download the bidding documents for e-submission from PPMO's Website www.bolpatra.gov.np/egp. Bidders shall deposit **NRs.5,000.00** as the cost of bidding document in the following bank .

- ६। Pre-bid meeting shall be held at **Gangajamuna Rural Municipality Office** at **12:00 hours on 09/07/2021**.
- ७। Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp. **to office of Gangajamuna rural Municipality on or before 12:00 hours on 22/07/2021**. Bids received after this deadline will be rejected.
- ८। The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hours on 22/07/2021** at the office of **Gangajamuna Rural Municipality, Phulkharka, Dhading**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to minimum of **NRS 18,00000.00** which shall be valid for 30 days beyond the validity period of the bid.
- ९। If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
