- A complete set of Bidding Documents may be purchased from the office of Gangajamuna Rural Municipality by eligible bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 3,000 till 12th Ashoj 2077 upto office hours.

- Sealed bids must be submitted to the office Gangajamuna Rural Municipality by hand/courier on or before 12:00 on 13 Ashoj 2077. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00, 13 Ashoj 2077 at the office of Gangajamuna Rural Municipality, Phulkharka, Dhading. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security, amounting to a minimum of mentioned amount for each project, which shall be valid for 30 days beyond the validity period of the bid (i.e. 150 days).
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date.
