- 1. Gangajamuna Rural Municipality has allocated funds towards the cost of following projects and intends to apply part of the funds to cover eligible payments under the Contract. Bidding is open to all eligible Bidders.
- 2. Gangajamuna Rural Municipality invites sealed bids from eligible bidders for the following projects under National Competitive Bidding procedures.
- 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Gangajamuna Rural Municipality, www.gangajamunamun.gov.np.
- 4. A complete set of Bidding Documents may be purchased from the office of Gangajamuna Rural Municipaplity by eligible bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 3,000 till 12th Ashoj 2077 upto office hours
- 5. Information to deposit the cost of bidding document in Bank:

- 6. Pre-bid meeting shall be held at Office of Gangajamuna Rural Municipality at 14:00, 29th Bhadra 2077.
- 7. Sealed bids must be submitted to the office Gangajamuna Rural Municipality by hand/courier on or before 12:00 on 13 Ashoj 2077. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00, 13 Ashoj 2077 at the office of Gangajamuna Rural Municipality, Phulkharka, Dhading. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security, amounting to a minimum of mentioned amount for each project, which shall be valid for 30 days beyond the validity period of the bid (i.e. 150 days).
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission working day shall be considered as the last date.
